Work Schedule and Location:

Actor shall perform services at the location(s) designated by Production Company and according to a mutually agreed schedule.

Production Company reserves the right to modify the schedule with reasonable notice.

Obligations of Actor:

Actor represents and warrants that they have the legal right and authority to enter into this Agreement and to perform the services described herein. Actor agrees to perform services professionally, to comply with all reasonable directions and requirements of the Production Company, and to maintain confidentiality regarding all non-public information related to the production.

Actor agrees to comply with all applicable laws and regulations, including but not limited to those governing work authorization and intellectual property rights.

Obligations of Production Company:

Production Company agrees to provide a safe and professional working environment, to compensate Actor as agreed, to comply with all applicable laws and regulations, and to respect Actor's rights under this Agreement.

Rights and Ownership:

Actor grants Production Company the exclusive, worldwide, royalty-free right and license to use Actor's name, likeness, voice, performance, and biographical material in connection with the production, promotion, distribution, and exploitation of the production in all media now known or hereafter devised in perpetuity.

Confidentiality:

Actor agrees not to disclose any confidential or proprietary information obtained during the course of engagement without prior written consent of Production Company, except as required by law.

Termination:

Either party may terminate this Agreement for cause upon written notice if the other party materially breaches any provision and fails to cure such breach within a reasonable time. Upon termination, all rights and obligations hereunder shall cease except those intended to survive termination.

Representations and Warranties:

Each party represents and warrants that it has the full power and authority to enter into this Agreement and that the execution and performance of this Agreement will not violate any other agreements or obligations.

Indemnification:

Actor agrees to indemnify, defend, and hold harmless Production Company and its affiliates from any claims, damages, or liabilities arising out of Actor's breach of this Agreement or gross negligence.

Dispute Resolution:

Any disputes arising under this Agreement shall be resolved by binding arbitration under the rules of the American Arbitration Association in the jurisdiction of the Production Company's principal place of business, and judgment upon the award rendered by the arbitrator(s) may be entered in any court having jurisdiction.

Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflicts of law principles. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.

Relationship of Parties:

Actor is an independent contractor and nothing herein shall be construed to create an employer-employee, partnership, or joint venture relationship between Actor and Production Company.

Entire Agreement; Amendments:

This Agreement, including any exhibits or schedules attached hereto, constitutes the entire agreement between the

parties and supersedes all prior oral or written agreements. Any modifications must be in writing and signed by both parties.

Severability:

If any provision of this Agreement is found to be invalid or unenforceable, the remainder of the Agreement shall remain in full force and effect, and the invalid provision shall be replaced by a valid provision that most closely reflects the parties' intent.

Waiver:

No waiver of any breach or default hereunder shall be deemed a waiver of any preceding or subsequent breach or default.

Force Majeure:

Neither party shall be liable for failure or delay in performance due to causes beyond their reasonable control, including acts of God, war, terrorism, government actions, labor disputes, or natural disasters.
