The Client represents that they have the authority to enter into this Agreement and that any materials provided do not infringe on any third party rights.

Termination:

Either party may terminate this Agreement upon written notice if the other party breaches any material term and fails to cure such breach within a reasonable period. Upon termination, the Client shall pay for all Work performed to date, and the Artist shall deliver all completed portions of the Work.

Indemnification:

Each party agrees to indemnify, defend, and hold harmless the other party from and against any claims, damages, liabilities, costs, and expenses arising from breach of this Agreement or violation of law by the indemnifying party.

Limitation of Liability:

Neither party shall be liable for any indirect, incidental, consequential, or punitive damages arising out of or relating to this Agreement, even if advised of the possibility thereof. The total liability of either party shall not exceed the total fees paid under this Agreement.

Confidentiality:

The parties agree to keep confidential all proprietary or non-public information exchanged in connection with this Agreement and to use such information solely for purposes of performing this Agreement.

Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of law provisions. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.

Dispute Resolution:

Any disputes arising out of or relating to this Agreement shall be resolved first through good-faith negotiation. If unresolved, disputes shall be resolved by binding arbitration in accordance with the rules of the American Arbitration Association.

Entire Agreement:

This Agreement constitutes the entire agreement between the parties regarding the subject matter hereof and supersedes all prior agreements, understandings, and negotiations, whether oral or written. Any amendments must be in writing and signed by both parties.

Severability:

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.
