Purpose of Agreement:

This Agreement is entered into by and between the members of the Band named above (collectively referred to as "Band Members") for the purpose of defining the terms and conditions regarding the formation, operation, and management of the Band, including but not limited to rights, duties, and obligations of each Band Member.

1. Band Member Roles and Contributions:

Each Band Member agrees to contribute their musical skills, time, and effort to the Band's activities including rehearsals, recording, performances, and promotional events. Specific roles such as lead vocalist, instrumentalist, songwriter, or manager shall be agreed upon by the Band Members and documented separately.

2. Decision Making and Management:

Decisions regarding the Band's activities, including bookings, expenditures, and creative direction, shall be made by majority vote of the Band Members. In the event of a tie, the matter may be escalated as agreed herein or deferred until consensus is reached. Management duties may be assigned to one or more members or third parties.

3. Ownership of Intellectual Property:

All original music, lyrics, recordings, compositions, trademarks, and related intellectual property created by the Band or its members in connection with the Band's activities shall be jointly owned by the Band Members unless otherwise agreed in writing. Use, licensing, and royalties related to such intellectual property shall be shared in accordance with the Band Members' agreement.

4. Revenue Sharing:

All income generated from the Band's activities including but not limited to performances, merchandise sales, recording royalties, and licensing fees shall be collected and distributed among Band Members according to their mutually agreed shares documented separately. Accurate records must be maintained.

5. Expenses and Financial Obligations:

Expenses incurred in the course of Band activities such as equipment purchase, travel, marketing, and recording costs shall be approved by majority vote and shared among Band Members as agreed. Reimbursement policies must be established and respected.

6. Term and Termination:

This Agreement shall remain in effect until terminated by mutual agreement of the Band Members or pursuant to provisions herein. A Band Member may withdraw from the Band upon written notice, subject to obligations regarding ongoing commitments and financial settlements.

7. Confidentiality:

Band Members agree to keep confidential any proprietary information, unreleased material, business plans, and personal information shared in connection with the Band and its activities, except as required by law or agreed by all members.

8. Dispute Resolution:

Any disputes arising out of or relating to this Agreement shall first be attempted to be resolved by good faith negotiation among Band Members. If unresolved, the dispute shall be submitted to mediation before any legal action. This Agreement shall be governed by the laws of the United States and the state mutually agreed upon by Band Members.

9. Amendments:

Any amendments or modifications to this Agreement must be made in writing and signed by all Band Members to be effective.

10. Entire Agreement:

This Agreement constitutes the entire agreement among Band Members with respect to the subject matter hereof and supersedes all prior agreements, understandings, and representations whether oral or written.

11. Severability:

If any provision of this Agreement is held to be invalid, illegal, or unenforceable, the remaining provisions shall continue in full force and effect.

12. Signatures and Execution:

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same document. Electronic signatures and PDF copies shall have the same force and effect as original signatures.
