

CONTEST RULES AND REGULATIONS

1. Eligibility

The Contest is open only to individuals who meet the eligibility requirements established by the Organizer and comply with all applicable laws and regulations. Employees, affiliates, and immediate family members of the Organizer are not eligible to participate.

2. Contest Period

The Contest begins and ends at the dates and times specified by the Organizer. All entries must be received during the Contest Period to be eligible. The Organizer reserves the right to modify, suspend, or terminate the Contest at any time without prior notice.

3. How to Enter

Participants must follow the submission instructions provided by the Organizer. Entries must be original and created solely by the participant. Multiple entries may be allowed as specified, but any fraudulent or duplicate entries will be disqualified.

4. Judging and Winner Selection

Entries will be evaluated by a panel of judges appointed by the Organizer based on the criteria published at the time of the Contest announcement. Decisions of the judges are final and binding in all respects. The Organizer reserves the right to withhold prizes if no suitable entries are received.

5. Prizes

Prizes will be awarded as described in the Contest announcement. Prizes are non-transferable, non-exchangeable, and no cash equivalents will be provided except at the Organizer's sole discretion. The Organizer reserves the right to substitute prizes of equal or greater value.

6. Notification and Claiming of Prizes

Winners will be notified by the Organizer using the contact information provided in the entry within a reasonable time after winner selection. Winners must claim their prizes as instructed by the Organizer. Failure to respond or comply with notification requirements may result in disqualification and selection of an alternate winner.

7. Publicity Release

By participating, entrants grant the Organizer the right to use their name, image, likeness, and entry materials for promotional purposes in any media worldwide without further compensation, unless prohibited by law.

8. Intellectual Property

Entrants warrant that their submissions are original and do not infringe on any third-party rights. The Organizer shall have the right to use, reproduce, modify, and display entries for purposes related to the Contest and promotion thereof, without additional compensation.

9. Privacy

Personal information collected from participants will be used in accordance with the Organizer's privacy policy and applicable laws. Participants consent to the collection, use, and disclosure of their information as described.

10. Limitation of Liability

To the maximum extent permitted by law, the Organizer and its affiliates, employees, agents, and sponsors disclaim all liability for any damages, losses, or injuries arising out of participation in the Contest or the acceptance, use, or misuse of any prize.

11. Disputes

Except where prohibited, participants agree that any disputes arising out of or related to the Contest shall be resolved individually, without resort to any form of class action, and exclusively by binding arbitration in the jurisdiction specified by the Organizer, under the laws of the United States.

These Contest Rules and Regulations are governed by, and construed in accordance with, the laws of the United States and applicable state law, without regard to conflict of law principles.

13. Modification and Termination

The Organizer reserves the right to modify, suspend, or cancel the Contest or these Rules at any time without prior notice. Any attempt to undermine the legitimate operation of the Contest may be a violation of criminal and civil laws and will result in disqualification.

14. Severability

If any provision of these Rules is found invalid or unenforceable, the remaining provisions shall remain in full force and effect.
