DECLARATION

I, _____, a resident of the State of Michigan, declare this to be my Last Will and Testament, revoking all prior wills and codicils. I am of legal age, of sound mind, and under no duress, fraud, or undue influence.

APPOINTMENT OF PERSONAL REPRESENTATIVE

I appoint _____ as Personal Representative to serve without bond and with full power to administer my estate according to law, including the power to sell, lease, or mortgage real or personal property, pay debts, taxes, and expenses, and distribute my estate as provided herein.

PAYMENT OF DEBTS AND EXPENSES

I direct that all my just debts, funeral expenses, and expenses of administering my estate be first paid from my estate.

GUARDIANSHIP OF MINOR CHILDREN

If at my death any of my children are under the age of eighteen years, I nominate and appoint _____ as guardian of their persons and estates.

SIMULTANEOUS DEATH CLAUSE

If my spouse and I die simultaneously or under circumstances making it difficult to determine who died first, I direct

that my estate be distributed as if I predeceased my spouse.

NO-CONTEST CLAUSE

If any beneficiary under this Will contests this Will or any of its provisions and loses, then in that event, I revoke any gifts, benefits, or interests in my estate given to that person by this Will.

POWERS OF PERSONAL REPRESENTATIVE

The Personal Representative shall have all powers allowed by law, including but not limited to: selling property, settling claims, investing assets, and making distributions, without court approval.

GOVERNING LAW

This Will shall be governed by and construed in accordance with the laws of the State of Michigan.
